Apologies were received from Councillors Howard Blake and Alison Heler
- HPC22/3/03** To receive declarations of Members' interests

- HPC22/3/04** To receive an update from the police covering Haslington Parish
PCSO Lizzie Jolley provided an update on local policing matters
- HPC22/3/05** Public Participation
A resident requested an update relating to the Speed Indicator Devices and requested that further information on meetings are published
Haslington Parish Allotment Society provided an update and advised of their upcoming open day

Councillor Edgar provided an update which included:-
 - A request has been made for costs relating to the installation of a footpath between the car park and the Baptist Church on Hassall Road
 - A request has been made for the cost of resurfacing Palmerston Close
 - The broken bench and lamppost following the road traffic accident on Crewe Road in Winterley has been reported to the police and information has been passed on to the insurance company
 - A resident has offered to set up a Speed Watch Group to monitor Crewe Road and a request has been made to the Parish Council for its support in the scheme
